Announcement about a competition for the position

Postdoctoral internship (post-doc position)

Based on art. 118a Act of July 27th 2005 r. – Law on Higher Education, (unified text; Journal of Laws 2017, item 2183, with later amendments), with the consent of the Rector of University of Warsaw, I announce a competition for the position of a postdoctoral internship (post-doc position) at the Institute of Archaeology in project "Settlement of the Sąspow Valley from Palaeolithic up to Modern timeselaboration of the unpublished fieldwork results of prof. Waldemar Chmielewski" financed by the National Science Centre, grant NO 2016/22/E/HS3/00486

Terms of employment: full contract, fixed-term employment contract for a period of 24 months beginning on the 1st of March 2019. 84 000 PLN annually.

Requirements:

- finished archaeological, geological or biological studies
- PhD in archaeology, biology or geology
- has received a PhD degree no earlier than 7 years before the year of employment
- specialized in bioarchaeology
- experienced in archaeological fieldworks
- experience in working in interdisciplinary research team
- very good, documented academic achievements
- a very good knowledge of foreign languages, among them English.

Description of tasks:

- collecting samples at archaeological sites
- conducting laboratory analyses within the field of specialisation
- coordination of the process of flotating samples and their inventarisation
- management of the interdisciplinary laboratory analysis process

Required documents:

1) An application letter for the offered position, addressed to the Dean of the Faculty of History with **consent clause:**

- 3) Document confirming the obtaining of a doctoral degree in the last 7 years, and in the case of a person who does not have a PhD degree but have a date for the defence of a doctoral dissertation, a certificate of setting a date for defending a dissertation
- 4) Scientific CV containing a list of publications, scholarships, awards and other distinctions resulting from conducting scientific research, scientific achievements, completed internships and courses, and experience in excavation.
- 5) Short description of previous research and upcoming research plans (max 500 words);
- 6) Recommendation letter of an independent research associate;

Competition procedure:

Application should be submitted until 05th December 2018. The commission board evaluates applications. The Commission reserves the right to invite all or selected candidates for interviews to verify the data contained in the application. A possible interview with the candidates will take place on 10th-14th December 2018. Based on the commission's ratings, a ranking list is created, sent to candidates electronically. The internship will be awarded to the person who obtains the highest number of points. The internship can be awarded to the next person on the ranking list, when the winner of the competition resigns from signing the contract. The commission's decision cannot be appealed. The results will be given on the 7th of January 201r.

INFORMATION CLAUSE
